I. Call to Order:

The business meeting was called to order at 1pm by President Kyle Weisholtz

- II. Report of Officers:
  - A. President (Kyle Weisholtz, Stevens Institute): Kyle thanked Monmouth University for hosting today's meeting. Since next year is an election year, members were asked to consider volunteering to join the executive board. If anyone is planning to attend the ACHA meeting in Boston, email Kyle so a NJCHA gathering can be planned.
  - B. Vice-President (Joe Henson, Seton Hall University): A host school is needed for the fall 2023 meeting in October, please contact Joe if interested. The winter meeting will tentatively be hosted by Drew University. So far, three speakers have been secured for the fall meeting and topics include vaccines and disordered eating. MACHA (Mid-atlantic College Health Association) updates: as member-at-large for MACHA, Joe attended the executive board meeting on May 17. There has not been much activity since Covid, but there is planning for future events which may

include a conference in 2024. There will be a MACHA meeting during the ACHA conference on June 1 from 12-1 for anyone attending ACHA. Reach out to Joe with any ideas for speakers and topics for future NJCHA meetings.

- C. Treasurer (Kathleen Dolan, Rowan University): Current total assets from the TD account and PayPal are \$9,631.40. Expected additional income is approximately \$2,945 and includes membership dues, as well as fees collected from conference attendees and vendors. Expenses include website fees \$1600-partial installment for new website; \$638 for general liability insurance. Other outstanding expenses include costs incurred from conference (food, continuing education credits) and tax filings.
- D. Corresponding Secretary (Holly Heller, TCNJ): the NJCHA website is being revamped, we hope to have it up and running for the fall.
- E. Recording Secretary (Joan Galbraith, Drew University): Meeting minutes from the January 2023 General meeting were emailed to membership prior to today's meeting. No corrections were requested and the minutes were approved as written.
- F. Committees and By-laws (Janice Vermeychuk): Janice reminded the membership to consider providing feedback to the NJ Department of Health, who is in the process of revising New Jersey Administrative Code Title 8 Chapter 57, which covers Communicable Diseases and related topics. The current rule is set to expire on February 8, 2024. NJDOH is seeking input from all stakeholders, and this is a good opportunity to provide input. Deadline to submit feedback is on May 31.

IV. Presentation of Awards (presented by Barbara Ackerson, Montclair State University-MSU, Co-Chair of Awards Committee with Sue Graziano, MSU (not present)): Congratulations to the following award recipients:
